2. Dressage whips must be maximum of 110 cm (43.3 inches)
3. Biting rules for U.S.A Eventing apply

5. Management reserves the right to cancel, split or combine classes.
6. Cross country will be shorter than U.S.A. Eventing rules.
7. Body protectors required for novice, recommended for all classes.
8. ASTM/SEI headgear required.
9. NO REFUNDS after closing date.

**DIRECTIONS to Poway Valley Rider's Association located at 14336 Tierra Bonita Rd. Poway 92064:**

**From I-15:** Exit Camino Del Norte, drive east 1.6 miles, Camino Del Norte will become Twin Peaks, continue 2.3 miles. Turn right at the Tierra Bonita traffic light. PVRA is .3 miles on the right.

**From Highway 67:** Drive Poway Road 2.6 miles turn right at the Espola Rd. traffic light. On Espola Rd. drive .7 miles and turn left at the Twin Peaks traffic light. Drive .2 miles to Tierra Bonita traffic light turning left. PVRA is .3 miles on the right.
